



Estudiantes cuyos padres no tienen o no desean proporcionar un número de Seguro Social (SSN)

La entrevista en línea de RDS depende del número de seguro social (SSN) u otro número identificable para verificar los datos de las agencias estatales de Carolina del Norte para ayudar a probar su beneficio de residencia en Carolina del Norte para fines de matrícula. Si su padre/madre/tutor legal decide no ingresar un número de identificación, la entrevista en línea de RDS determina que usted es un no residente. **RDS quiere que la entrevista inicial en línea sea fácil y útil para todos, pero se da cuenta de que algunos estudiantes pueden tener una situación de vida única, que no se puede capturar fácilmente a través de la entrevista en línea. En estos casos, los estudiantes tienen la posibilidad de solicitar una apelación y proporcionar otra información para demostrar su residencia en Carolina del Norte.**

En el proceso de apelación de RDS, los especialistas de RDS trabajan individualmente con el estudiante (y los padres) para una determinación de residencia. En esta apelación, los estudiantes tienen la capacidad de proporcionar información adicional, documentación, responder preguntas y hacer preguntas de RDS. Esto proporciona a los estudiantes que inicialmente reciben una determinación de no residente la oportunidad de explicar más a fondo su situación y proporcionar documentación adicional.

1. El estudiante completa el perfil de RDS (si el estudiante aún no tiene una cuenta de CFNC) y termina la parte del estudiante de la entrevista en línea de RDS.
2. En la sección Padres, si el padre tiene un ITIN u otro identificador en lugar de un Número de Seguro Social (SSN), elija la primera opción, "deberá proporcionar un número de identificación diferente". Aparecerá una pantalla donde se puede ingresar.
